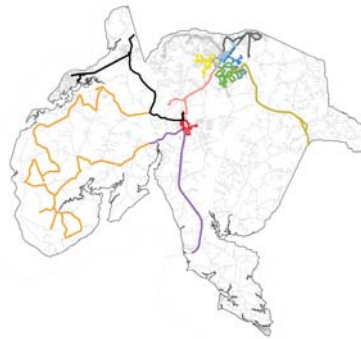




Public Transportation Schedule/Timetable

* **Note:** the final 9:00 PM departure is a "by request" service and only those destinations requested by that passengers who board at the transfer point are served; no additional passengers are picked up on the final run.

 **Holiday Service – the last loop on designated holidays departs the Waldorf transfer point at 6:00 PM and operates by request only.**

The St. Charles East B route is a residential circulator serving the Carrington, Wakefield, Sentry Woods, and Huntington neighborhoods of St. Charles, with stops also at Northgate Place and Gallery Place. Businesses in Smallwood Village Shopping Center and along Industrial Park Drive, such as the MVA and Fuller Transitional House, are also served on this route. East B is one of only two routes that serve the St. Charles Towne Center Mall. Passengers from other routes can transfer to East B for mall service at the Waldorf transfer point.
